Know Your Rights, Resources and Options

Howard University is committed to providing a learning and working environment free from sex or gender-based discrimination and harassment, including sexual and domestic violence. You have the right to make a report to the Title IX Office and/or to the Howard University Department of Public Safety or local law enforcement, as well as seek any health, counseling, or other support services you may need from a confidential resource, on or off campus.

Counseling, Advocacy and Support Services

Reporting Resources

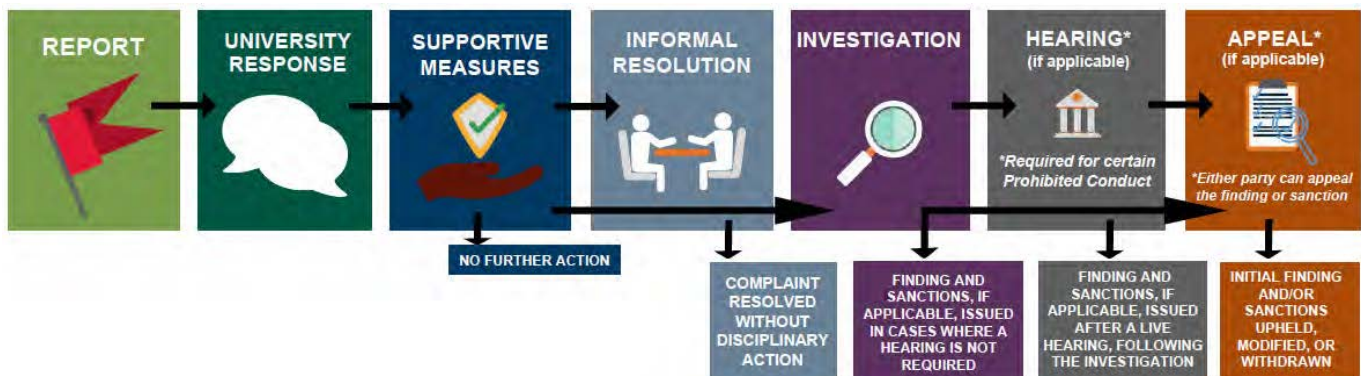
You may make a report to the University's Title IX Office and/or the Department of Public Safety. Each option has its own, separate set of procedures and potential outcomes. You may choose to pursue one or both options, in addition to utilizing any of the confidential resources described on the previous page. You are not required to file a complaint with law enforcement and opting not to do so does not prevent you from pursuing a complaint with the University through the Title IX Office (and vice versa).

The Title IX Office

You may file a report with the **Title IX Office** via phone (202-806-2550), email (TitleIX@howard.edu), or the online reporting form available on the Title IX Office website (www.howard.edu/title-ix). There is a range of responses available through the Title IX Office, including:

- **Supportive Measures** – e.g., ensuring access to counseling and medical services; no contact orders; assistance with a change in class schedule, work schedule, or job assignment; assistance with rescheduling exams and receiving assignment extensions; assistance with a change in University housing assignment
- **Investigation** – leads to potential disciplinary action for the respondent
- **Informal Resolution** – voluntary and does not lead to discipline
- **Referrals to other Departments/Offices for Resolution** – when the matter is not within the jurisdiction of the Title IX Office or is not otherwise appropriate for a response from the Title IX Office

The Title IX Office works with other campus offices to coordinate supportive measures. Requests for Title IX-related accommodations (e.g., academic, residential, or employment-related supportive measures) must be made directly to the Title IX Office.
